1 INTRODUCTION

For information on how to make a request for online transfer, on the procedures involved and on the eServices that are available, see the guidance on Direct online transfer of 2018 withholding data of nonresident recipients of pension.

We have made a number of annual changes to the specification for the year 2018.

However, it still has the same structure as previously.

The last date for direct online transfer requests is 8 November 2017.

3 HOW TO REPORT ADDRESS/NAME CHANGES OF THE PENSION INSTITUTION

If the pension institution or insurance company has changed its business name or address, the Tax Administration must be notified either by post, by e-mail or by fax.

4 DESCRIPTION OF THE FIXED-LENGTH FORMAT

The length of the filing is fixed at 650 characters. Enter all the information in character format. Positions 1 to 590 consist of information filed by the payor; positions 591 to 596 are the answer information sent back by the Tax Administration. Positions 597 - 650 are reserve spaces for the payor's use.

Data elements are placed according to their positions with no blank spaces between the fields.

Each filing begins with an 8-character identifier in uppercase letters.

Left-justify all alphabetical information. When the file has a fixed length, enter all information in character format. Enter leading zeroes in the fields where you report amounts of money. Write the euros and cents with no separator characters in between.

Example: For 1,681 euros and 89 cents, write 168189. If you do not know the amount of money, fill the field with zeroes. Do not write any minus or plus signs. Amounts of money cannot be negative.

Based on the Business ID of the party that made the request, the answer file is sent back and will include corresponding sets of data in answer to the request. Based on the Business ID of the pension insurance company or pension institution, the system will print its name on the letters and correspondence that goes to the recipients of pensions.

Computer service centres may have to differentiate between the Business IDs of some of their customers and compile file sets consisting of requests made by the same Business ID. They can make use of the reserve space in positions 597 - 650 for purposes of differentiation. The Tax Administration will not alter the value of these positions.

Each Type of Payment must be reported separately i.e. separate request filings must be created for each. If the Type of Payment is the same but there are differences between the types of pensions being paid, you must add them up and report the total, if the same facts are true for all of them.

531 - 540 PENSION INCOME FOR 2018

The payor's estimate for the taxable total of the pension or other comparable benefits that are going to be paid in 2018. Enter the amount as an integer, in cents, with no separator characters, and pad with leading zeroes. This amount must include any pension that is paid in the form of fringe benefits, valuated on the date of reporting.
