1 TECHNICAL GUIDANCE FOR PLATFORM OPERATORS' ANNUAL INFORMATION RETURN

Reporting platform operators must submit a return every year, to provide the information laid down in the Act governing the information-reporting requirement of platform economy operators to provide information in the field of taxation (Laki digitaalisen alustatalouden toimijoiden tiedonantovelvollisuudesta verotuksen alalla (1267/2022)) and in §17f of the Act on assessment procedure (Verotusmenettelylaki (1558/1995)). Finnish platform operators must provide information concerning the relevant activities carried out by sellers on their platform. In addition, platform operators reporting in Finland use this report to submit a nil report if they have no information to be reported for the reportable year.

The annual information return to be submitted by RPOs (reporting platform operators), is based on the OECD's DPI XML schema, which also addresses the EU's needs arising from the directive amending the directive on administrative cooperation in the field of taxation (EU 2021/514, the DAC7 Directive), and on the guidance of the DPI XML and User Guide schema. These instructions describe, from a technical perspective, the required submittals of information to the Tax Administration.

XML schema validations and XML example documents that meet the Tax Administration's M/O (Mandatory/Optional (P/V)) terms are attached with these instructions. The schema version valid at each time is applied to reporting. Only one schema for one information flow is used in Ilmoitin.fi.

These instructions apply to annual information returns submitted after 1 January 2023. The parties responsible for submittal are expected to follow the instructions issued by the Finnish Tax Administration. More information on the obligations of RPOs submitting reports to Finland is available in The information-reporting requirement of a Reporting Platform Operator (DAC7).

The structures, elements, Ilmoitin.fi checks and submitting procedures defined in these instructions are valid in the test environment (https://testi.ilmoitin.fi/) from 27 May 2025. In the live environment (www.ilmoitin.fi), the structures, elements and check processes are valid starting 10 June 2025.

1.1 Document reading instructions

This guide is primarily for **providers of digital platform information (DPI)**.

The characters in the lower right-hand corner of each element carry the following meanings:

- 0...∞: the element can be repeated from 0 to n times.
- 1...∞: the element can be repeated from 1 to n times.

An element highlighted with a uniform line means a mandatory element, which must always be included. If an element is highlighted with a dotted line, it is voluntary in the Schema. However, a voluntary element can be mandatory in some situations, in which case the element must carry information. These elements' presence and content are checked in Ilmoitin.fi.

2 THE ILMOITIN.FI SERVICE

RPOs can only submit their annual information returns in electronic format, through Ilmoitin.fi. The service is available browser-based and additionally in the form of a Web Services API. Ilmoitin.fi first validates the structural and formal correctness of the arriving information returns, and then sends back error messages and comments to the submitter. For detailed descriptions of the checks, see section 8 below.

Testing and production (=live) environments of Ilmoitin are available. The testing environment's browser-based service is available on https://testi.ilmoitin.fi/. The production environment is available at www.ilmoitin.fi/. You can send e-mail to tamo.tk@vero.fi to request the addresses of the Web Services APIs.

Electronic identification is required to submit data. You can check the identification method required for each data flow, and check the point the data flow where the authorisation is verified here.

The sender must name the annual return file submitted through Ilmoitin.fi according to the MessageRefld of the file (if for example the MessageRefld is DPI-1234567-8-2025-001, the name of the file must be DPI-1234567-8-2025-001.xml.) Among the checks made by Ilmoitin is the validation of the filename format. Ilmoitin will also add an indication of the electronic channel being used and a timestamp in front of the filename of any arriving return or message. Accordingly, an example of a full filename looks like this: V_20260131_101010_DPI_2025_DPI-1234567-8-2025-001.xml.

2.1 Technical factors related to files

Maximum file size is 100MB. If size exceeds 100MB, the information must be divided into files of less than 100MB. If the reported information is divided into several files, i.e. reports, each report must have a unique MessageRefld. It is recommended that consecutive numbers are used in MessageRefld and DocRefld.

Submitters must use the UTF-8 standard for encoding the annual information return. To ensure interoperability, characters of the ISO 8859-1 set and encoded in accordance with UTF-8 must be used. As a result, this means that no Cyrillic characters, among others, can be used. The file must not contain the Byte Order Mark (BOM) character.

Any special characters (especially & and <) must be converted as shown below

3 SUBMITTING THE RETURNS

RPOs must submit their annual information returns concerning any reportable calendar year by the end of January of the following year, as required by the provisions of the Act governing the information-reporting requirement of platform economy operators to provide information in the field of taxation. The return for the current year can be filed from 1st of April onwards.

4 SUBMITTING A 'NIL' RETURN

If an RPO has no information to be reported concerning a reportable period, the RPO must submit a 'nil' return.

The nil return is submitted by entering the RPO's identification information in the MessageSpec structure, and by setting the value DPI403 for MessageTypeIndic. In addition, the RPO's information must be entered in the PlatformOperator structure. No ReportableSeller structure is submitted.

In situations where an RPO submits an annual information return with another RPO's information in it, and the other RPO, because of this arrangement, refrains from submitting information, the other RPO must still submit a nil return. In this case, DPI403 must be set as the value in the MessageTypeIndic element, and "true" for AssumedReporting, and the first RPO's identification data must be entered in the AssumingPlatformOperator element.

Whenever a nil return is submitted, Ilmoitin.fi checks that the file does not contain a ReportableSeller structure.

5 MAKING CORRECTIONS

Corrections to the annual return of the reporting platform operator must be made either by filing a correction message with MessageTypeIndic DPI402 or by filing a deletion message. The correction message must always be filed according to the schema valid at the moment when the correction message is filed. Original and corrected annual returns must always be filed through Ilmoitin.fi gateway.

Individual structural parts of a return can be corrected or deleted. This way, corrections can be made to the returns so that several returns with the same DPI Body structure are corrected simultaneously, and the corrections concern individual structural parts. Each independent structural part (PlatformOperator, AssumingPlatformOperator, AssumedPlatformOperator and ReportableSeller) has a unique DocSpec_Type, which contains the DocRefld and DocTypeIndic elements, as well as CorrDocRefld for corrections. The returns concerning a correction/deletion must always refer to the DocRefld that is the most recent.

Using the DocTypeIndic element's values in a correction message:

- I. OECD0: Re-sent data
 - This is only used in the PlatformOperator structure when correcting or deleting individual structural parts using DPI402 as the value of MessageTypeIndic.
 - This is used when correcting or deleting the ReportableSeller and/or OtherPlatformOperator structure, and the PlatformOperator information has already been submitted before and it is not changed. In this case, DocRefld is the same as in the previously submitted return, and the previously submitted information is submitted again.
- II. OECD1: New data
 - This is always used when submitting new information, which has not previously been submitted or which has previously been deleted.
- III. OECD2: Corrected data
 - o This is used when previously submitted information is corrected.
- IV. OECD3: Deleted data
 - o This is used when previously submitted information is deleted.

Messages can contain new information (DocTypeIndic=OECD1) or corrections and deletions (OECD2 and OECD3). DocTypeIndic values OECD2 and OECD3 can only be used in correction messages (MessageTypeIndic=DPI402). New information with the DocTypeIndic value OECD1 cannot be entered in corrections, having DPI402 as their MessageTypeIndic.

When correcting or deleting information under a single structure, the entire structure must be submitted again, also regarding the elements located under the same structure whose information is not corrected. The new corrected or deleted structure replaces the entire structure to be corrected, including all its elements. For example, when correcting the amount of a consideration (Consideration) received from a relevant activity (RelevantActivities) under a

single ReportableSeller structure, all elements under the ReportableSeller structure and their data content, must be entered again.

When making corrections/deletions to the information in a ReportableSeller structure, the PlatformOperator structure has to be re-submitted (OECD0). If corrections need to be made to the ResCountryCode element or the JurisdictionGVS element or the country code of the address of an immovable property (ImmovableProperty/Address/CountryCode) in the ReportableSeller structure, the ReportableSeller structure must first be deleted and then re-entered as new information (OECD1). Even in case that a wrong seller has been submitted in the ReportableSeller structure, the entire ReportableSeller structure must be deleted (OECD3) and the details of the right seller must be submitted in a new ReportableSeller structure (OECD1).

Each correction message must have a unique MessageRefld. The MessageTypeIndic of an correction message is DPI402. The MessageSpec structure does not include CorrMessageRefld, and CorrMessageRefld located in the DocSpec structure is not used.

Platform operator structure can never be deleted (DocTypeIndic=OECD3) from the message. The way to delete an entire message is to delete all its other structures (DocTypeIndic=OECD3) and give PlatformOperator structure with DocTypeIndic=OECD0.

If the PlatformOperator structure needs to be corrected, the entire message must be deleted (DocTypeIndic=OECD3, MessageTypeIndic=DPI402) and the corrected return should be reported as new information (MessageTypeIndic=DPI401). When deleting information (DocTypeIndic=OECD3), you must re-submit the structure to be deleted without any changes.

The unique DocRefld to be corrected, referring to the most recent information, is indicated in the CorrDocRefld element. Your correction message must have a new unique DocRefld. To identify and correct a message and single record, MessageRefld and DocRefld must be unique; the same identification information cannot be used in other messages or their parts.

6 XML SCHEMA STRUCTURE

The schema structure is presented in general in the DPI XML Schema User Guide available on the <u>OECD website</u>. This section describes the structures requiring the User Guide's additional instructions and the automated checks made by Ilmoitin.fi, outside of the XML Schema.

The namespace used in the Schema is "dpi". The namespace cannot be presented globally. Instead, it must be used in conjunction with element names.

This section describes the technical part of the information return at a national level.


The instructions consist of the following sections:

- I. The sender, message type, contact person and reportable period are indicated in the return's MessageSpec structure.
- II. DPI Body consists of three subsections:
 - a. PlatformOperator, including information about the reporting platform operator.
 - b. OtherPlatformOperators, including information about other platform operators
 - AssumingPlatformOperator = The RPO that submits information on another RPO, either to avoid reporting (the same) information twice or because a platform operator with a reporting obligation in several Member States has chosen to only report all information in a single Member State;
 - ii. AssumedPlatformOperator = Each RPO, whose information another RPO has reported.

- c. ReportableSeller, including information about the reportable seller, including:
 - i. The seller's identification information (EntitySeller=company, or IndividualSeller=natural person),
 - ii. RelevantActivities contains the reportable seller's relevant activities.
- III. The identification information of platform operators and sellers (not natural persons) is reported in structures in accordance with OrganisationParty Type.
- IV. The identification information of sellers who are natural persons is reported in structures in accordance with PersonParty_Type.

6.1 MessageSpec

The structure contains information concerning the message type.

- The RPO's identification information is reported in this element.
- Finnish RPOs enter their Business ID.
- Foreign operators enter their Tax Identification Number (TIN).
- Ilmoitin checks that the element has been entered and that the identifier is the same as in the PlatformOperator/TIN element.

- A two-character country code (CountryCode) (ISO-3166-1 Alpha 2 standard)
- Ilmoitin makes a check to ensure that the value is always "FI" (Finland) in the annual information returns relating to the platform economy.

- The value is always "DPI" in the annual information returns from RPOs.

- The first and last name, telephone number, email address and/or group email address of the contact person who provides more information about the return must be given here.
 - o The telephone number must be entered with the area code in international format.
 - o The name, telephone number and e-mail address must be separated by a comma (,).
 - If several contact people or details are entered, they must be separated by a semicolon (;). Example: Steve Submitter, +358912345678, steve.submitter@domain.com; group.submitter@domain.com
- Ilmoitin checks that this element has been entered and contains information.
- Ilmoitin checks that the telephone number is in international format.

- A unique identifier, generated by the software, for the annual information return of the RPO in question.
- Maximum length 80 characters.
- The sender must ensure that MessageRefld is not the same as in any of the returns submitted previously by the RPO. If information is divided across several files, i.e. messages, each one of them must have a unique MessageRefld.
- The software that generated the file must create the identifier using the following information: message type (DPI), the RPO's Business ID/TIN, year of payment, a consecutive number. Example:
 - o Original annual information return DPI-6606611-7-2025-1.
- Ilmoitin checks that the platform operator's ID in MessageRefld is the same as the ID entered in the SendingEntityIN element.
- Ilmoitin checks that DPI has been selected as the message type in MessageRefld.
- Ilmoitin checks that the information is in correct format: message type business ID/TIN year consecutive number.
- Ilmoitin checks and displays an error message if the ID is the same as in the RPO's previously submitted annual information return.

- This element indicates the type of information that is being sent:
 - o DPI401: The message contains new (including additional) information.
 - DPI402: Correction or deletion message, where individual structural parts of previously sent information is being corrected or deleted.
 - DPI403: The message indicates that there is no information to report a Nil Return.
 - This is used when the RPO has nothing to report about reportable sellers.
 - The nil return is also used when a RPO registered in another country submits information on behalf of another RPO belonging to the same entity or because several RPOs are required to report the same information.
 - Whenever a nil return is submitted, Ilmoitin will check that the file does not contain any ReportableSeller structure.

- The calendar year for which the information return is submitted.


- The final day of the reportable year must be in the YYYY-12-31 format. For example, an annual information return submitted for 2025 must have "2025-12-31".
- Ilmoitin checks that ReportingPeriod is in the YYYY-12-31 format.
- The operator that has the information-reporting requirement must ensure that the annual information return is submitted for the correct year using the correct schema.
- Information returns can be corrected for six years after the end of the reportable year.

- The submitting operator must indicate the exact time when the annual information return was created, e.g. 2026-01-17T09:30:45 or 2026-01-17T09:30:45.123.
- Ilmoitin checks that the year in the timestamp is the current year.
- Note: The timestamp of any correction message must be later than the timestamp of the previously submitted annual information return.

6.2 DPIBody

The DPIBody structure contains information about the RPO and a platform operator on whose behalf another RPO reports its information (either to avoid reporting the same information twice or because a platform operator with a reporting obligation in several Member States has chosen to only report all information in a single Member State) and the relevant activities of reportable sellers. One information return can only include one single DPIBody structure.

- The DPIBody structure is voluntary in the Schema, but the Ilmoitin.fi service checks that the structure has been entered once and only once.
- The DPIBody structure consists of the following three elements:





6.2.2 OtherPlatformOperators

- This structure is for reporting either:
 - in the AssumingPlatformOperator structure, the identification information of the RPO that submits information on behalf of another platform operator either to avoid reporting the same information twice or because a platform operator in Finland has chosen a single legal person's branch or main company established in another Member State to submit an annual information return on their behalf;


or in the AssumedPlatformOperator structure,

- the identification information of each RPO, whose information the platform operator indicated in the PlatformOperator element reports. (This information/element is entered by the platform operator that submits information, and it submits the identification information of all the platform operators whose information it submits to avoid reporting the same information twice or because the branch or main company established in another Member State of the platform operator in Finland has chosen it to submit information on their behalf.)
- the information on each RPO, on whose behalf the platform operator indicated in the PlatformOperator element submits information. (This is indicated by the RPO that names all the platform operators, on whose behalf they are submitting information.)
- The information must be submitted if any RPO submits information on another RPO, either to avoid reporting (the same) information twice or because a platform operator with a reporting obligation in several Member States has chosen to only report all information in a single Member State.

 For more information, see the Tax Administration's detailed guidance "The information-reporting requirement of a Reporting Platform Operator (DAC7)", section 5 Exceptional circumstances of submitting the information.

6.2.2.1 AssumingPlatformOperator

The structure contains information on the platform operator assuming the reporting in the name of the RPO, whose identification information has been given in the PlatformOperator element.



Example:

Platform Z is operated by two RPOs: Platform Operator A (domiciled in Country 1) and Platform Operator B (domiciled in Country 2). To meet the information-reporting requirements, Platform Operator A has received a statement of affirmation from Platform Operator B that Platform Operator B will submit information about all the reportable sellers in Country 2 on behalf of Platform Operator A.

Platform Operator A:

- enters its identification information in the PlatformOperator element;
- indicates in the MessageTypeIndic DPI403 element that the information return is a nil return:
- selects AssumedReporting = true so that the tax authorities in its country of residence know that Platform Operator A has assigned the fulfilment of its information-reporting requirement to another platform operator;
- enters the identification information of Platform Operator B in the AssumingPlatformOperator element;
- leaves the ReportableSeller element blank.

Platform Operator B:

- enters its identification information in the PlatformOperator element;
- selects AssumedReporting = false;
- enters the identification information of Platform Operator A in the AssumedPlatformOperator element;
- enters the relevant activities of A and B in the ReportableSeller element.

- The element can be repeated.

- The TIN of the country of residence of the platform operator that submits another platform operator's information is entered in this element.
 - Enter the TIN without the country code and special characters, such as the slash character (see instructions in section 2.1 Technical factors related to files)
- A repeatable element if there are several TINs
- Attributes
 - issuedBy
 - The two-character country code (CountryCode) (ISO-3166 Alpha 2) of the country that issued the TIN is entered in this element.
