



CLAIM FOR PROGRESSIVE TAXATION OF EARNED INCOME

This form for requesting the progressive taxation of earned income is for use by permanent residents of foreign countries, or individuals staying six months or less in Finland.

Residents of EEA countries or countries with which Finland has signed a tax treaty have the option of requesting that the 35% tax at source be replaced by progressive taxation of earned income (not including dividends).

Report all the income you have earned in Finland, earned income taxed in your country of residence, and the related deductions. Finland will only collect taxes on your income earned in Finland; however, the taxable income you have earned in your country of residence will raise the tax rate applied to your earned income in Finland.

If your taxable earned income and the related deductions are not yet known by the tax authorities in your country of residence, please enclose your payslip, certificate of unemployment allowance, pension decision, or some other reliable account of your income.

Residents of EEA countries earning at least 75% of their income in Finland may request that their other income earned outside Finland be disregarded in the Finnish tax assessment. Enclose a certificate, issued by the tax authorities in your country of residence, on earned income for which you have paid taxes and on any deductions that have been made in your country of residence. Approval of your request is conditional on providing this certificate.
