

Cancellation of Online Power of Attorney

Here are instructions on how you, as a representative of a principal, can cancel an Online Power of Attorney that has been created by an agent on your behalf and approved by you earlier. (If more than one representative of a principal was originally marked in the Power of Attorney, the Power of Attorney will expire if any one of the representatives cancels it.)

You have been sent notification via email concerning the approval of the Online Power of Attorney. The email message contains a link through which you can cancel the Power of Attorney. You can cancel the Power of Attorney electronically if you have personal online banking codes or an ID card with a chip.

If you cannot verify your identity by electronic means, you can cancel the Power of Attorney via the Tax Administration's [Katso registration facilities](#). Bring with you the notification you received via email, or the summary version given to you upon the approval of the Power of Attorney, which contains the ID of the Power of Attorney.
