## 1 DESCRIPTION OF THE EXAMPLE

This example describes the correction process of a report when it is noticed that part of a previously paid payment becomes an overpayment, or unjust enrichment.

The employer has a valid pension insurance policy with an earnings-related pension provider, so the earnings-related pension provider data and the pension policy number are submitted in the earnings payment report. The accident insurance company details are not specified because the employer has insured all of its employees with one accident insurance policy.

In this example, monthly wages have been paid and a housing benefit and a telephone benefit have been granted. The payer collects a compensation for the housing benefit. Part of the monetary wages (EUR 500) changes into an overpayment, and the payer corrects a previously submitted report. The example describes this replacement report. Some complementary data to an earnings payment report, such as employment relationship data, has been specified in the example. Always check the instructions concerning the payment situation and enter all data matching the payment situation in question.

The data used in the example is not real. Always use correct data that matches the payment situation.
