1 DESCRIPTION OF THE EXAMPLE

In the example, an employee of a foreign employee leasing company has started working in Finland in the service of a Finnish service recipient. The employee lives abroad and is a non-resident taxpayer in Finland. The leased employee's country of residence has a valid tax treaty with Finland, according to which Finland has the right to tax the wages of the leased employee. In this kind of a situation, the foreign employee leasing company must submit an employee leasing notice in the Forms for working abroad (WorkForm) data group.

The employee leasing notice must be submitted for every leased employee regardless of the duration of their work. The data must be submitted when the tax treaty between the employee's country of residence and Finland does not prevent Finland from taxing the employee's wage income or when there is no tax treaty. The data must include the estimated duration of the work assignment, the details of the Finnish service recipient and the details of the representative of the foreign employer. Furthermore, an estimate of the amount of wages for the entire tax year must be reported.

In the example, a foreign employer pays monthly wages to a foreign leased employee working in Finland. The employee is insured in his/her home country, so he/she does not need to be insured in Finland. The payer does not collect taxes from the wages, because a foreign employer does not have an obligation to pay taxes to Finland. The income earner pays his/her taxes as tax prepayments. The employee is not insured in Finland, so data needed for earnings-related pension or accident insuring is not provided in the report, such as information on the earnings-related pension insurance or occupational class.

The minimum earnings payment report data has been provided in the example. Always check the instructions concerning the payment situation and enter all data matching the payment situation in question.

The data used in the example is not real. Always use correct data that matches the payment situation.
