1 DESCRIPTION OF THE EXAMPLE

The monthly wages paid to an income earner in June were EUR 500 too high. The overpayment is discovered in July. The payer submits a replacement report, on which the overpayment is reported as an unjust enrichment. At the same time, the payer adjusts the social insurance contributions collected from the employee.

The payer and income earner agree that the overpayment is recovered in August. Wages are paid normally to the income earner in July. The recovery to be made in August is not reported in conjunction with the July wages because, according to the Incomes Register's guidance, recovery must be reported on the report submitted during the pay period when income is recovered. In addition, a new processing rule allocated to the recovery date prevents reporting if the recovery date is later than the payment date submitted on the report.

Data about the recovery made in August is provided on the August report. Tax is withheld from the gross wages paid. Withholding from the recovered amount is reported in additional recovery details, as it has no impact on the withheld tax. If withholding from the recovered amount was higher than the amount reported under income type 402 (Withholding tax) and the payer adjusted withholding incorrectly, the report would be rejected on the basis of processing rules for 2022. A negative amount cannot be reported for income types 402 (Withholding tax) or 404 (Tax at source) in conjunction with recovery.

The data used in the example is not real. Always use correct data that matches the payment situation.

Annual changes 2022: The value for 'Recovery date (RecoveryDate)' cannot be later than the payment date or other reporting date specified on the report.

The value for 'Recovery date (RecoveryDate)' cannot be earlier than 1 January 2019.

The value for 'Start date (StartDate)' of the original pay period (OrigPaymentPeriod) cannot be earlier than 1 January 1800 AND the value cannot be later than the value of 'Recovery date (RecoveryDate)'.

If even one income type on a report has the value for 'Recovery' set as 'True', a negative 'Amount' value cannot be entered for income types 402 (Withholding tax) or 404 (Tax at source).
